

Abstract Guidelines

The abstract must be submitted in English according to the following features:

1. Line spacing must be simple and alignment must be justified.
2. Title:
 - a. Maximum size: 120 characters;
 - b. **Bold** (don't use italics or underlined);
 - c. **Don't** include names of authors of *taxa*;
 - d. **Don't** use the final point (.);
 - e. The title must be written in Title Case (not UPPER CASE).
3. The content of the abstract:
 - a. Size: maximum 2,000 characters including spaces;
 - b. **Don't** include citations;
 - c. **Don't** include figures and tables;
 - d. Names of genera and species should appear in italics, which **must be indicated as follows**:
`\textit{Cornitermes culmunas}`, `\textit{Apis mellifera}`. That is, the prefix `\textit` + left parenthesis + species name + right parenthesis
 - e. **Do not use italics for other words in your abstract.**

FAQ: What is the reason for not using italics? **Answer:** The system (LaTeX) doesn't recognize words in italics in Word, only the words written as in the model appear in italics in the final edit. The authors are responsible for adapting the abstracts to the standards, and this will be considered as an evaluation criterion.

4. Authors:
 - a. Must be presented as follows: "Maria F. Silva (1); José M. Souza (2)" (separated by semi-colons, without final point);
 - b. Insert at most five (5) authors. If you include more, the last names will be automatically deleted.
5. Filiation:
 - a. Must be presented as follows: "(1) Universidade Federal de Viçosa; (2) Portland State University" (separated by semi-colons, without final point).
6. Email address:
 - a. Put only the e-mail of the main author.
7. Keywords:

- a. Each abstract must include three keywords that define the subject and allow the summary index. These words must be typed on a single line and separated by commas, without final point.
8. Financial Support:
 - a. Just one line, separated by comma;
 - b. Don't use final point.
 9. You need to be precise and accurate when sending your abstract, which will be published exactly as it was received. The content of the abstract is the responsibility of the authors.
 10. Your abstract must be drafted in a text editor and saved in ".Doc". We will not evaluate abstracts submitted in other formats.
 11. The Scientific Committee reserves the right to reject abstracts that do not follow the standards.
 12. Abstract format:

This is an example for the summary. Do not submit mere records or simply reaffirm biological facts already established. Do not include any nomenclatural act, because it is against the standards of the ICZN. Abstracts should be informative, short and objective. It is essential to present the results and a conclusion. The limit of the abstract is 2000 characters including spaces. Use the default \textit {Name name} for italic type, exclusive for species names. Do not use any type of formatting for anything else, except for the title bold.
